- ( ) Full Membership Each Applicant for Full Membership must be recognized as an auctioneer in his/her community for a period of (1) year previous to his/her application for membership & conducted a minimum of twelve (12) public auctions. Annual dues are \$100.
- ( ) Associate Membership Each applicant for Associate Membership must be employed as an auctioneer by an Association member's auction firm, or be a graduate of a recognized auction school. (Note: Associate Members have a full voice in all discussions – but no vote. Annual dues are \$80.
- ( ) Affiliate Membership Applicants for Affiliate Membership shall include those individuals who business works directly or closely with the auction profession. The Membership Committee shall determine eligibility requirements for all Affiliate Membership applications. Annual dues are \$100.

**NOTE – ADDITIONAL REQUIREMENTS:**

1. Each applicant must be sponsored by a member in good standing of the Association.
2. **A check for initiation fee of \$50 plus first year's membership dues must accompany the application.**
3. Each applicant must attend a minimum of one general membership meeting before the application for membership will be brought before the membership for consideration.
4. Applicant's name will be advertised (read) twice before coming to a membership vote for acceptance.
5. Following a favorable membership vote of acceptance, the applicant will be welcomed into the Association.
